FOSTER AGREEMENT TERMS

Foster agrees to provide transfer of the animal to any events/appointments that Milo's Dog Rescue sets up and if you can not then you agree to give the rescue 48 hours notice.

Foster agrees **not** to transfer custody of the animal to anyone other than Milo's Dog Rescue and agrees to return the animal to the Rescue upon demand.

Foster agrees to contact Rescue **immediately** if the animal becomes ill or is missing. We recognize that dogs being dogs will occasionally make a run for the hills, so please let us know immediately if the dog is missing. Likewise, animals do become ill and we need to know.

Foster will provide fresh food, fresh water and plenty of exercise daily.

Foster agrees to not rename our animal and to call him/her by the name provided.

Foster agrees to provide weekly updates and photos to the Rescue on the animal's progress. We want to know how you and the pet are doing.

Foster agrees to inform the Rescue **immediately** if falling in love with our pet and is considering adopting.

Foster agrees to always transport this animal in a safe manner and never loose in the open bed of a pick-up truck or in any other unsafe manner.

I have been advised that my foster pet may have been neglected, mistreated, or abused and that special care or precautions may be required. I also understand that the animal may need medical care which will be provided by Rescue. Rescue animals frequently come in to rescue scared, underweight, and/or ill.

I have been advised that a foster pet will need time to adjust to new routines, new family and new surroundings. In additions, I am aware that the animal may need training in basic house manners.

I agree to carefully introduce the new pet to the existing dogs and cats. Coming to a new home is stressful for the new animal and your existing animals. Careful introduction is a must. Your new foster needs time and space to adjust to the surroundings and your existing animals need to feel they are not being replaced or crowded. Introducing the new animal can result in growling, barking, submissive urination or other undesirable behavior. Properly managing the introduction is therefore important.

Foster agrees to always keep the foster dog within a fenced yard (not on a chain) or supervised on a leash. Foster agrees to never leave the dog outside when no one is home, to never allow the dog to be tied to a doghouse or a chain, nor left unsupervised in a yard for extremely long periods.

I have been advised that foster dogs can sometimes dig, chew, soil, and exhibit other undesirable traits. I understand that dogs are dogs and will do things that cannot be foreseen on occasion

I understand that interactions between my child(ren) and the new dog must be carefully supervised. Any dog in rescue is carefully screened, but dogs are dogs and unpredictable on occasion and especially in new surroundings. I agree that I will never leave my child alone and unsupervised with the dog as I realize that one mistake on my part can result in injury and in the dog never having a home.
